Examples such as these may require a rapid response and school closure at very short notice. Whilst closure at short notice will be challenging for all stakeholders and particularly for families trying to return to work, we are prioritising the safety of staff and children so if necessary Headteachers will make the decision to close. Any decision taken to close the school will be made as quickly as possible by the Headteacher in consultation with the Executive Heateacher. In the event one or more of the federation schools having to close, or partially close, families will be notified and communicated in the following ways:

by text message – parents should ensure the school has up to date mobile telephone numbers and contact details for nominated family members

details will be posted on the school website.

In school distancing and procedures as outlined in the risk assessment will be implemented while waiting for pupils to be collected. \acute{A}

Parents will be contacted by text and/or phone to collect pupils immediatelyÁ All staff will be notified Á

Website homepage will display key information including "we urge you not to phone school because we need to keep the telephone lines clear for staff" Á All those affected will be given testing advice and asked to inform the school of the outcome Á

Public Health England, The Local Authority and Chair of Governors will be informedÁ

The Executive Headteacher and Headteacher will assess the risk and determine whether longer term closure is required and communicate appropriately. Communication should clearly state the reason for closure to avoid unnecessary anxiety. Á
